Verordnung

vom 12. Juli 2005

betreffend die Abänderung der Verordnung über Massnahmen gegenüber Liberia

Aufgrund von Art. 3 Abs. 1 des Gesetzes vom 8. Mai 1991 über Massnahmen im Wirtschaftsverkehr mit fremden Staaten, LGBL 1991 Nr. 41, unter Einbezug der aufgrund des Zollvertrages und der Fremdenpolizeilichen Vereinbarungen anwendbaren schweizerischen Rechtsvorschriften und in Ausführung der Resolutionen 1521 (2003) vom 22. Dezember 2003, 1532 (2004) vom 12. März 2004 und 1579 (2004) vom 21. Dezember 2004 des Sicherheitsrates der Vereinten Nationen verordnet die Regierung:

Abänderung bisherigen Rechts

Die Verordnung vom 25. Januar 2005 über Massnahmen gegenüber Liberia, LGBL 2005 Nr. 17, in der Fassung der Verordnung vom 3. Mai 2005, LGBL 2005 Nr. 86, wird wie folgt abgeändert:
